All gas powered boats and Personal Water Craft's (PWC's) on Lake Harmony are required to display a boat sticker. The cost per property owner for the 2010 season is \$40.00 per gas powered watercraft. Each additional watercraft will have a fee of \$40.00 per sticker. All applicants are required to provide a current/valid registration, along with a copy of the liability insurance, for each sticker requested. All property owners must be in good standing with their respective associations before being issued a sticker.

Renters are required to obtain a temporary sticker at a cost of \$50.00 per boat sticker. Renters must provide COPIES of the lease, a valid registration, and liability insurance, ALL documents must be in the same name or names. NO exceptions will be made.

Gas powered boats and PWC's not displaying a sticker is considered trespassers and will be asked to leave. Anyone not complying with the rules and regulations of The Lake Harmony Group Inc. will be considered in violation and will be subject to legal action.

Please complete the enclosed application and return it along with the required documents and a check made payable to Lake Harmony Group in the envelope provided.

I/We understand that Lake Harmony is a privately owned Lake and as the owner of a gas powered watercraft I must display a boat sticker and that my use of Lake Harmony as well as the use by any of my renters or guests is completely at our own risk and I/we agree to hold harmless the owners of Lake Harmony, their employees, directors, officers and agents.
